

AUTHORIZING AND DIRECTING THE EXECUTIVE DIRECTOR OF THE HOUSING AUTHORITY OF THE CITY OF MILLVILLE TO POST AND FILE A SCHEDULE OF ALL MEETING OF THE MILLVILLE HOUSING AUTHORITY AS REQUIRED BY THE OPEN PUBLIC MEETINGS ACT OF 1975; AND DESIGNATING CERTAIN NEWSPAPERS TO RECEIVE SAID NOTICES AS REQUIRED UNDER THE OPEN PUBLIC MEETINGS ACT FOR THE YEAR 2010

WHEREAS, the Open Public Meetings Act of 1975 requires that a schedule of regular meetings of the Millville Housing Authority be posted annually and maintained in one public place reserved for public announcements, and requires the annual notice be filed and maintained by the Clerk of the City of Millville;

WHEREAS, Section 3 of the Open Public Meetings Act of 1975 requires that notice of any meetings to be submitted to two (2) newspapers, one of which shall be the official newspaper, and the second a newspaper which has the greatest likelihood of informing the citizens of the City of Millville;

AND WHEREAS, the Open Public Meetings Act of 1975 requires that notice of any meetings of the Housing Authority of the City of Millville not provided for in the annual schedule must be (1) posted in at least one public place reserved for public announcements; (2) mailed, telephone, sent by telegram or hand delivered to at least two newspapers designated by the public body; and (3) filed with the Clerk of the municipality.

NOW THEREFORE, BE IT RESOLVED BY THE HOUSING AUTHORITY OF THE CITY OF MILLVILLE that the Executive Director is hereby authorized and directed to post and maintain posted on the official bulletin board located in the housing authority Administrative Office at 1153 Holly Berry Lane, Millville, New Jersey, a copy of the attached schedule of regular meetings of the Millville Housing Authority for the year 2010; and to file a copy of said notice with the office of the City Clerk
